Contactless giving project

Thanks to the National Church, in July we delivered 45 contactless giving machines to participating parishes, who received subsidised devices. We are looking forward to a second round in the coming months.

Top Tips

... for saying "thank you" to your church community

According to a survey from the Church of England last year, less than a third of Anglicans say they are regularly thanked for their giving. As we emerge from the difficult season that the pandemic has brought, here are some ways that you might like to recognise people's support of your church.

- 1 Make a thank you announcement in a 'back to church' service, acknowledging the ways people have given and served during the pandemic.
- 2 Celebrate stories of generosity with a generosity wall, to which all ages can add pictures and messages.
- **3** Write thank you letters or cards from your incumbent or PCC treasurer.
- **4** Give thanks for people's gifts given in all ways (standing orders, PGS, online, etc) in your intercession or as you pray over the offering.
- 5 Put a thank you message in your parish newsletter or church notice sheet.
- 6 Post on social media with an update of how any fundraising is going.

Parish Giving Scheme (PGS) success at St Paul's, Thamesmead

St Paul's joined PGS in January, and have seen over half of their planned givers make the switch to the scheme. Patrick, their Team Rector told us, "it helps greatly that we can rely on that money coming into our account on the same day each month. Since day one, everything has worked smoothly. Donors have found it easy to join and our treasurer is happy because it greatly reduces her workload with the Gift Aid claimed *automatically.*" Do watch our recent
