Scam update

Ruth Martin and the Archdeacons advised you of the scam perpetrated on one of our parishes. As you may have heard, we are very grateful that the bank has been generous and will reimburse the church concerned. Nevertheless, we would ask you to be vigilant: "no matter how persuasive and how convincing, the access codes and passwords to accounts of your church – or your private accounts – must not be released to anyone. Please always speak to your bank direct first and only using the numbers you have been given on your bank correspondence or if possible, visit a branch."

Fixing your energy rate

Every day, between six and eight churches are moving on to fixed rate energy contracts through Parish Buying. Many are finding the Parish Buying quotations a competitive alternative. If you'd like them to get you quotes for 1, 2 or 3 years or if your contract still has some time to run, then just let Parish Buying know on the <u>application form here</u> and they'll be in touch

Are you getting reduced-rate VAT on your church's energy?

Churches should always fill in a charity declaration when signing up with their energy supplier (or even afterwards if they forgot at first). Every company has its own form, and once accepted, your church will be charged only 5% VAT and will be exempt from Climate Change Levy (CCL). CCL. Churches will generally be eligible for 100% relief, but some church halls will not be able to claim 100% charitable use. This is made clear on the form. It applies to electricity, to gas, and to oil. See the <u>HMRC guide here</u>.
