

Parish Legacy Co-ordinator

How you can support your church by encouraging wills and legacies





Your role

The role of a Parish Legacy Co-ordinator is to act as the main point of contact for legacies (also known as gifts in wills) within a church. This involves encouraging church members to keep their wills up to date and consider the difference a gift in their will could make to their local church.

You will provide a friendly, supportive and confidential ear to church members who want to talk about writing their wills or leaving legacies.

Main objectives:

To help the parish community:

- 1. Understand the importance of writing a will as an act of Christian stewardship;
- 2. Encourage gifts in wills to further resource the church's ministry and mission.

Core tasks include:

- Encourage the PCC to make and communicate a PCC Legacy Policy (see our PCC leaflet about legacies).
- Work with clergy to launch and communicate the policy with the congregation. This could include clergy preaching on the theme.
- Act as the main point of contact in the parish for all legacy enquiries.
- Ensuring the church honours and thanks families when legacies are received.
 This could include an annual service of thanksgiving.
- Being available for individuals who want to talk about legacies.

Many people know it's a good idea to write a will, but never quite get around to it!

To help make it easier, the Church of England has partnered with **Farewill**, the nation's favourite will-writer, to enable you to write your will online, in as little as 30 minutes, for free.

Personal Specification

- Sensitive to people and able to maintain totally personal confidentiality.
- A good listener.
- Well organised, used to dealing with paperwork.
- Well respected, liked and trusted within the church community.
- Enthusiastic about giving to resource God's mission.
- Preferably has made their own will including a charitable legacy.
- Desirable but not essential: knowledge of financial and legal affairs.

Your role is not to give advice but to signpost to further information and appropriate professionals, so you don't need specialist knowledge.

Approach

- Don't be afraid to talk about the importance of gifts in wills; they can transform a church's ministry and mission!
- Never disclose confidential information to a third party, including the clergy.
- Make information about legacies and wills available in a low key, sensitive way over the long term.
- Pray, listen and speak with love, hope and understanding.
